

PAN AMERICA TAEKWONDO UNION GENERAL CHILDREN COMPETITION OUTLINE \*This document has been created to safeguard competition for Children Taekwondo Sparring competitors on ages between 6-11 years old. It is important to mention this is the first year these rules are enforced and are susceptible to be under the PATU Games Committee recommendation.

## **DRAW SHEETS & BRACKET PUBLICATION**

The draw sheets and brackets will be daily published, one (1) day before the start of competition on the following (social) media platforms on www.patutkd.org.

## **COMPETITION RULES**

Primarily WT Competition Rules & Interpretation for Cadets athletes will be applied. Please note that only light contact to the head is allowed for children.

## **COMPETITION SYSTEM**

Single elimination tournament system.

## **CONTEST TIME**

Children divisions: 3 rounds of 1 minutes, 45-seconds break between each round. The PATU Technical Delegate has the authority to adjust the contest time as he sees fit.

## **ELIGIBILITY REQUIREMENTS**

- 1. Member of the team/club of a pertinent Member National Association, recognized by Pan American Taekwondo Union.
- 2. Holder of Taekwondo Grade certificate from 2<sup>nd</sup> Kup and above.
- 3. A participant in order to be eligible for participation must be born in:
- 6/7 Years Old 2015-2016
- 8/9 Years Old 2013-2014
- 10/11 Years Old 2011-2012

All competitors must prove their age by presenting their passport or identification card at the official weigh-in. All athletes must sign a written consent (please find enclosed on the last pages) at the registration, signed by one of the parents or legal guardians, accepting their participation and all parts of the official invitation.

# **COACH ELIGIBILITY REQUIREMENTS**

- 1. Minimum age of 18 years.
- 2. Coach is **not** allowed wearing Dobok.
- 3. Coaches must wear formal attire for final and semifinal matches.

# **SPORT EQUIPMENT**

#### PSS – system

Daedo International Generation 2, with electronic headgear are provided by the OC. Face protector with face shields must be used.

#### Dobok and protective equipment

Athletes can only use WT recognized products while participating at the event. See a list of recognized products at: http://www.worldtaekwondo.org/wtf-partners/recognized/

Only WT-recognized equipment is allowed groin-, forearm-, shin-, mouthpiece, Daedo sensor socks and gloves shall be brought by the contestants, which is mandatory. Sensor socks will not be provided by the organization. Daedo Sensor socks will also be on sale at the venue.

#### FIELD OF PLAY REGULATIONS

By accepting an accreditation card, all accredited persons agree to comply with the Field of Play regulations applicable at Taekwondo events. Only the competitors and their coaches will have admittance with valid accreditations to the contest areas. Children's guests, parents or companionships without accreditation is not allowed by NO means inside of the Field of Play.

#### AWARDS

#### Individual awards

1<sup>st</sup> place – gold medal and certificate

- 2<sup>nd</sup> place silver medal and certificate
- 3<sup>rd</sup> place two bronze medals and certificate

All participants will receive a certificate of participation.

## ACCESS TO FIELD OF PLAY

Only for one (1) coach, one (1) athlete and one (1) officially licensed Medical Doctor are allowed to enter the Field of Play with their official accreditation. The OC has the right to refuse participants or extra people access to the Field of Play.

## **SPORT ENTRIES - ONLINE REGISTRATION**

Registration of Children participants is only possible through the OC registration picked system.

**On-site Change of medal event (weight division) and/or other modifications \$** 25 USD for each change, payable at the registration desk. All changes after the registration deadline shall be done on-site.

#### **BANK DETAILS**

We highly encourage for all entry fees to be wire transferred to the Organizing Committee' bank account accordingly with the Event Outline, prior to the event registration deadline.

#### **NO REFUND**

The Organizing Committee does not refund entry fees paid. In case the athlete has not been removed from the list of participants before the deadline his/her team or official must fully (100%) pay the entry fee(s) for participation. In case of no show the invoice will be send to the team after the tournament.

#### **INDEMNITIES**

It is the responsibility of each registering team to ensure that their athletes and team officials have filled out the indemnification forms correctly and have duly signed them, thereby indemnifying WT, PATU, the Organizing Committee and all other officials and athletes from any claims of injuries, losses or otherwise arising in the course of participation for every Taekwondo Tournament during 2022 or any activities linked therewith.

It is the responsibility of each registered team to ensure and guarantee that sufficient insurance coverage has been arranged for all athletes, team officials and other participants. Without sufficient insurance coverage, teams will not be allowed to compete.

Please fill out the Personal Indemnity Forms and return them to the Organization Committee before the competition day for every event. Each participant (athletes, team officials, etc.) must fill out the indemnification form.

## **MEDICAL INSURANCE**

All participating athletes, coaches and team officials shall have mandatory a medical insurance that covers medical care and in case of emergency repatriation to home country. All relevant documents proving that such an insurance is present, including insurance policy papers, should be taken to the event in case a medical situation occurs.

## **CORONA COVID-19 OUTBREAK**

#### General

The OC cannot predict the developments in the next comings months regarding the Corona COVID-19 outbreak in the Pan American Region. The teams must bear in mind that due to the uncertain nature of the Corona COVID-19 outbreak and sole authority of each government on how to respond, re- strictions to access the Host country may be applicable. It is the responsibility of each participating team to make sure they meet all entry requirements in order to enter the Host country and to monitor international policies with regards to country entries.

#### Sufficient insurance

The teams are strongly urged and advised to make sure to have their own sufficient travel, cancellation and medical insurance.

#### Liability

In this respect, please be informed that the OC shall not and cannot be held liable for any expenses and costs incurred by the teams for travelling to the event in case of cancellation of the event due to (further) outbreak of the Corona COVID-19 virus in the Host Country. The teams are strongly urged and advised to make sure to have their own sufficient travel, cancellation, and medical insurance. The OC shall not accept any claims or requests for compensation in case of cancellation of the event.
