COMPETITION RULES

WT Competition rules for Cadets, along with PATU competition rules for minors.

COMPETITION SYSTEM

Single elimination tournament system for Kyorugi and Cut-off system for Poomsae

CONTEST TIME

Kids Divisions. 2 rounds of 90 seconds x 45 second break.

The PATU Technical Delegate has the authority to adjust the contest time as he sees fit.

ELIGIBILITY REQUIREMENTS

1. Approval of the National Federation.
2. Member of a national team representing one of the Member National Association, recognized by Pan American Taekwondo Union or World Taekwondo;
3. An athlete in order to be eligible for participation must be born in:

- 2011-2016

All competitors must prove their age by presenting their passport or identification card at the official weigh-in: and written consent must be submitted (please find enclosed on the last pages) at the registration, signed by one of the parents or legal guardians, accepting their participation and all parts of the official invitation

COACH ELIGIBILITY REQUIREMENTS

1. Minimum age of 18 years;
2. National Coach Certificate;
3. Paid Entry Fee.

Coach is **not** allowed wearing Dobok, formal attire is required for semifinal and final rounds.

Under 19 kg	Not exceeding 19 kg

Under 27 kg	Over 23 kg and not exceeding 27 kg
Under 31 kg	Over 27 kg and not exceeding 31 kg

APPLICABLE FEES

- Entry Fee – one (1) Division: \$40 USD per Athlete registered
- Entry Fee – two (2) Division: \$50 USD per Athlete registered
- Entry Fee – three (3) Division: \$60 USD per Athlete registered or per poomsae team registration

SPECTATORS

Spectators pay the following admission fees:

- 1 – Day admission: 100 pesos or 5 USD
- 2 - Day admission: 150 pesos or 10 USD



PAYMENT

All entry fees shall be pay on site in cash

NO REFUND

The Organizing Committee does not refund entry fees paid. In case the athlete has not been removed from the list of participants before the deadline his/her team or official must fully (100%) pay the entry fee(s) for participation. In case of no show the invoice will be send to the team after the tournament.

SPORT EQUIPMENT

PSS - system

Daedo International Generation 2, with electronic headgear are provided by the OC.For Black Belts.

Non- Electronic Scoring chest gear will be use for colour belt grade. Each athlete will be sole responsible of bringing its sport equipment.

Dobok and protective gear

Athlete are allow to use the sport equipment recognized by WT and PATU, while participating at the event (Daedo, Adidas, Tusah, Kwon, Anta, JCalicu). It is only allow to use the white dobok and the NOC code on he back of the uniform.

POOMSAE COMPETITION

- Each MNA of PATU can participate with up to two (2) athlete in each division. But each one of the contestant will be able to partipated in a maximum of three (3) events, one Poomsae individual divisions, one freestyle and only one (1) team for pair, male team, female team and freestyle

- Recognize Poomsae Individual (Male & Female)
- Freestyle Individual (Male & Female)
- Recognize Poomsae Pair / Freestyle Pair
- Recognize Poomsae Male Team (3 Athletes)
- Recognize Poomsae Female Team (3 Athletes)
- Freestyle Team (5 Athletes)

FIELD OF PLAY REGULATIONS

By accepting an accreditation card, all accredited persons agree to comply with the Field of Play regulations applicable at Taekwondo events.

Only the competitors and their coaches will have admittance with valid accreditations to the contest areas.

AWARDS

Individual awards

- 1st place – gold medal and certificate
- 2nd place – silver medal and certificate
- 3rd place – two bronze medals and certificate

All participants will receive a certificate of participation.



Special Awards

- Best Referee Male / Female
- Best Coach Male / Female
- Best Kyorugi Black Belt Team Male / Female (1st to 3rd place)
- Best Poomsae Black Belt Team Male/Female (1st to 3rd place)

REFEREES

PATU Technical Delegate and the Organizing Committee will determinate the number of National and international referees assigned to the event;

- Round trip flight cost shall be covered by each on of the international referees assigned.
- The LOC will cover three (3) day of hotel and meals, check in on OCT 12 – Check out OCT 15, 2022.
- The LOC will pay a per diem, per day of competition, the amount will be determinated at the end of event registration.

The Referees' technical meeting will take place according with the PATU scheduled.

FIELD OF PLAY - ACCESS

Only A coach (1), and athlete (1) and a doctor (1), shall access to the field of play with their official accreditation card. The LOC has the right to denied the access to the FOP of any participant.

MEDIA AND PRESS

Media Accreditation

Registered media and press officials or official photographers are entitled to receive a media and press accreditation card.

Photo Positions

All accredited photographers are only allowed to use the designated photo positions while working in the Field of Play. By accepting a media and press accreditation, the accredited person agrees to follow at all times the instructions of the Colombia Taekwondo Federation and Press officer.



ACCOMODATION

The event is organized as a bio-secure environment, due to that all national team must book their accommodation on the official hotel through the travel agency that will assist in this topic. Any member of the team that does not follow this accommodation rules, will be banned from event participation
