GENERAL PROVISIONS:

This is an event from the World Taekwondo and the Pan American Taekwondo Union, Level G2 Kyorugi & G2 Poomsae.

ELIGIBILITY AND COMPETITOR RATES (on EUR):

All participants must satisfy the following requirements in order to participate. This is an "Open" event, open to all ages and belt levels. Ages 12 years & over Black Belts must have current 2022 Global Athletes License (GAL) to register.

- All athletes must hold passport or birth certificate of the country they will represent.

- Competitors will compete at the age based on their birth year -Early Registration Fee (ends April 28, 2022):

€ 100.00 for the first event. Extra € 50 for each event additional. (two events maximum by athlete)

-Regular Registration (ends May 15, 2022):

€ 125.00 for the first event. Extra € 65 for each event additional.

- -Late Registration Fee (ends May 25, 2022):

€ 150.00 for the first event. € 80 extra for each event additional.

ELIGIBILITY AND COACH FEE (in ELR):

- All Coaches must be at least 18 years of age, current Global Official License (GOL) and World Taekwondo Coach Permit Level 1 holders.

- Trainers who do not provide Level I Certificate as proof of current WT

trainer will not be allowed to enter the event.

- Early Registration Fee (ends April 28, 2022):
- € 100.00.

If you register and pay for a division at early/regular period and then add a new division at regular or late registration period, you will be charged the difference between two registration periods for your first division and pay respective fees for the period registered for your 2nd division. For example: If you register during the early registration period and paid \in 100 EUR and then add additional division during the Final Registration date period (16-25 May, 2022), you will be charged \in 150 EUR for the addition you have made and pay \in 75 EUR for the registration fee difference from the early registration to the final registration fee for the first division.

REGISTRATION FEES ARE NON-REFUNDABLE WITH NO EXCEPTIONS

CHANGES AND FEES (on EUR):

All change requests made after May 25, 2022, including name change, event change, etc. will result in a EUR €100 administration fee per change request.

- Changes before May 25, 2022: WT Simply Compete.

- Changes after March 25, 2022 must be submitted with Change Request Form (see Page 12) and EUR €100 Change Fee onsite on June 2, 2022.

- If you make a weight category change within the same registration period that you registered and paid it will be FREE.

- If you make a weight category change in a different registration period from when you initially registered and paid, you will be charged the difference e.g. Registered and paid during early bird (until April, 28 2022) you can change any time during this period for FREE. If you then change weight category during regular (Apr 29 – May 14) you would be charged the difference between regular and early registration fee. If you change weight category during late registration period (May 16-25) you will be charged the difference between late and early registration fee.

DRAW OF LOTS:

All athletes will be seeded according to WT World Ranking as of March 20, 2022. A minimum of 25% seeding for all divisions according to the WT ranking bylaw. The draw sheets and brackets will be available one (1) day before the start of the competition of the respective weight category.

COMPETITION REGULATIONS:

Current WT Kyorugi and Poomsae Competition Rules will govern the 2022 La Havana Open.

ENTRY FEES, TERMS & CONDITIONS OF PARTICIPATION:

-All Registration for Athletes, Coaches, and Officials must be completed through the World Taekwondo Event Registration System: <u>https://worldtkd.simplycompete.com.</u>

- All athletes, coaches and officials must have an approved 2022 Global License (GAL or GOL) before registering.

- Round trip airfares, ground transportation, and room and board expenses shall be borne by all participants.

- World Taekwondo and the Pan American Taekwondo Union have a NO REFUND policy.

- NO REFUNDS will be given for any reason after registration has been completed.

REGISTRATION & PAYMENT PROCESS:

Athletes, Coaches and Team Officials must register for the event through worldtkd.simplycompete.com.

Please pay online during registration on WT Simply Compete.

WT GMS accepts credit card payments ONLY. All online payments are subject to a mandatory credit card processing fee based on the total event registration due. Registration will not be confirmed until payment is received.

DO NOT wait until the last minute to register/pay.

Failure to submit payment by the early registration deadline will result in late payment fees with no exceptions. Payments made on-site after WT Simply Compete Late registration deadline will not be subjected to extra fees, but will be adjusted to late registration fees.

ANTI DOPING REGULATIONS:

The WT Anti-Doping Rules, and where necessary, the Code of the World Anti-Doping Agency, shall apply throughout the competition. Compulsory anti-doping tests will be carried out for all finalists, while random tests will be conducted among the quarter and semifinalists who failed to advance to the (semi-) final. The WT and/or WADA may carry out random out of competition testing prior to the Havana Open.

TUE (Therapeutic Use who take any substance or medicine listed): In the "Prohibited List" of the WT Anti-Doping Rules and Anti-Doping Code of World Anti-Doping Agency (WADA) for therapeutic purposes are requested to visit the website of WADA and make online filing of their TUE applications on ADAMS http://www.wada-.org/en/ADAMS/ and report to the WT Sport Department at wtf.dopingfree@gaisf.org no later than May 25, 2022. INDEMNITIES:

Participants without proper participation entry forms and valid medical insurance coverage will not be allowed to compete at the Havana Open. Liability waivers must be signed by participants (or by parent or legal guardian for athletes ages 18 and under) prior to the release of credentials at check-in. Photo ID is required to pick up credentials during check-in and weigh-in.

WT INTERNATIONAL REREREES:

- Organizer will request the required number of WT International Referees.

- Referees who are interested in officiating for this event must apply through register through <u>www.tkdreferee.com</u>.

- Round-trip Airfare shall be borne by each participating International Referee.

- The Organizing Committee shall cover four (4) nights of room and board expenses (check-in in early afternoon of June 2, 2022).

- Please note: Referee meeting will be held at 4-7 pm on June 2, 2022 at the event venue.

- The Organizing Committee shall provide each participating WT International Referee with a per diem of EUR €100.00 per day for 3 days of competition.

NATIONAL REFEREES:

Rules from kyourugi and Format from competence

The committee organizer have right to change, Modify the duration from the rounds, divisions and drink decisions officers without previous warning.

HEAD OF THE TEAM / TECHNICAL MEETING:

PATU technical officials and WT Technical Delegate shall conduct the Head of Team meeting on Thursday June 2, 2022. Head of the team meeting location will be announced one week prior to event date.

The WT Technical Delegate and Organizing Committee have the rights to change, modify the duration of rounds, and combine divisions at the Head of Team meeting. The official draw will be done automatically and posted on the PATU official website.

OFFICIAL UNIFORMS:

All Sparring athletes must wear WT approved black V-neck white uniform (dobok) in good condition. Patches, embroidery, logos, team names, country names, athlete names, and stripes are permitted on uniforms.

NO TAPING IS ALLOWED ON ANY PART OF THE UNIFORM.

COACHES ATTIRE:

All coaches must oblige to wearing business suits (tie optional) for the semifinals and final rounds. Coaches that do not follow the dress code will not be allowed to enter the field of play during finals and semifinals.

SPARRING EQUIPMENT:

Organizer will be using DAEDO Generation 2 PSS & E head system for G2 sparring divisions ONLY. All competitors are REQUIRED to purchase and use their own Daedo sensor socks & heels for the sparring event(s).

All Sparring competitors are responsible for supplying their own gloves, arm, shin guards, groin guards and mouth guards. No eyeglasses or goggles, prescription or nonprescription, are allowed with no exceptions.

RECOGNIZED BRANDS:

All contestants are required to wear WT recognized doboks and protective equipment. The latest version of WT recognized manufacturers' list is available at the website of World Taekwondo http://www.worldtaekwondo.org/wtf-partnersrecognized/

Please Note: Organizer reserves the right to disallow any uniform or equipment if it is found to be offensive or degrading in any fashion.

KYORUGI COMPETITIONS:

CADET DIVISIONS (Ages 12-14) JUNIOR DIVISIONS (Ages 15-17) G-2 SENIOR DIVISIONS (Ages 17 & Over) BLACK BELTS

WEIGH-IN:

The weigh-in of the athletes ages 12 and over will take place at designated weigh-in area one (1) day prior to the start of the respective weight category of competition.

PLEASE REFER TO EVENT SCHEDULE FOR WEIGH IN TIME / DATE.

- All weigh-in athletes must present a form of government issued photo ID.

- At weigh-in, male athletes (except adults) must wear a minimal of underpants and female athletes (except adults) must wear a minimal of underpants & brassieres. Under NO circumstances may a cadet nor junior athlete weigh-in in the nudity.

- 100-gram allowance will be made for under aged athletes.
- Each athlete shall have one (1) attempt to pass the weigh in.

However, one (1) extra attempt is allowed for those athletes who did not qualify the first time. This extra attempt shall be done within the time limit of the official weigh-in hours on the same day.

- If an athlete wants to change weight at the time of registration, he/she may do so for a fee of €100.00. A test scale will be available outside of the weigh in rooms.

RANDOM WEIGH IN: All Kyorugi competitors are subject to this WT rules. Random weigh-in must be completed 1 hour prior to the beginning of each competition day.

Poomsar Rules and Competition Format

Organizing committee has the right to change, modify and make official decisions without prior notices.

HEAD OF THE TEAM / TECHNICAL MEETING:

PATU technical officials and WT Technical Delegate shall conduct the Head of Team meeting on Thursday June 2, 2022. Head of the team meeting location will be announced one week prior to event date.

Designated Poomsae will be posted on the PATU official website. www.patutkd.org

The WT Technical Delegate and Organizing Committee have the rights to change, modify competition format and combine divisions at the Head of Team meeting.

OFFICIAL UNIFORMS:

WT approved Y-neck Poomsae uniforms are mandatory for all competitors in all Poomsae divisions. Cadets and Juniors are allowed to wear Poom or Black Belt with Poomsae uniforms. Poomsae Competitors Age 14 and under must wear Poom Collar Y-neck uniforms.

COACHES ATTIRE:

All coaches must wear business suits (tie optional) for the semifinals and final rounds. Coaches that do not follow the dress code will not be allowed to enter the field of play during finals and semifinals.

FREESTYLE POOMSAE:

Competition shall start from the Final Round, and the top four individual competitors/pairs/team shall be awarded 1st, 2nd and two (2) 3rd place based on their total points in the final round.

In the case of a tie, competitor with the higher

Technical points win. 3rd and 4th places are awarded with bronze medals.

*Competitor(s) are allowed to use the same music and routine in the same division.

COMPETITION RULES & RANKING:

The Latest WT Poomsae Competition Rules and Poomsae Ranking bylaws will govern the 2022 Havana Open.

POOMSAE:

Cut-Off system and Single Elimination: Single Elimination will be used all Individual Recognized Poomsae divisions (U30 and U40).

Cut-Off system will apply to all remaining Poomsae competitions.

CUT OFF SYSTEM:

Preliminaries: When 20 or more competitors are participating; competition shall start from the Preliminary round with division of groups at different rings. Competitors shall perform one (1) designated compulsory Poomsae, and half of each group shall advance to Semi-Final based on the highest scores. In the Preliminary round, each group may be judged by a different group of judges. If the number of competitors is odd, the number of competitors will be rounded to an even number. Ex) If there are 23 competitors in the division, it will be considered as 24 competitors and 12 shall advance to Semi-Final.

Semi-Final Selection: When 9 to 19 competitors are participating; competition shall start from the Semi-Final round. Competitors shall perform one (1) designated compulsory Poomsae, and 8 of them shall be advanced to Final Round based on the highest scores.

Final: When 8 or fewer competitors are participating, competition shall start from the Final Round. Competitors shall perform two (2) designated compulsory Poomsae, and the top four individual competitors/pairs/team shall be awarded prizes based on their total points in the final round. In the case of a tie, competitor with the higher presentation points wins. 3rd and 4th places are awarded with bronze medals.
