#### 9. Competition Method

#### **KYORUGUI / POOMSAE**

 THERE IS NO RESTRICTION ON THE NUMBER OF ATHLETES PER DIVISION PER COUNTRY (as long as the eligibility requirements are met)

#### KYORUGUI

4 Olympic Weight Categories per gender for a total of 8 categories

#### POOMSAE

- Individual Recognized Poomsae (Male & Female)
- Mixed Pairs Recognized Poomsae
- Teams Recognized Poomsae (3)
- Freestyle Individual (male & female)
- Freestyle Mixed Teams (5)
- Freestyle Mixed Pairs & Individual Recognized Poomsae (Male & Female.)

### 10. Competition times:

#### Kyorugui

Best of 3 rounds (2 minutes x 2 or 3 rounds x 1 minute break) Times may ONLY be adjusted by the TD (Technical Delegate)

#### Poomsae

Recognized Poomsae no longer than 90 secs. Freestyle 90 – 100 secs.

#### 11. Awards:

### Ranking Points P8 for all participants in acoordance to their classification.

Medals for 1st, 2nd & 2 3rd places; Digital Participation Certificate for all participants









### 12. Classification Process for Junior Pan American Games Asuncion, 2025

Athletes who compete in the events will obtain points form the U21 PanAmerican rankin, which will give them the possibility of Qualifying directly to the Asuncion 2025 Junior Pan American Games. (The regulations will be published)


