- Individual recognized Poomsae (Male & Female)
- Mixed Pairs recognized Poomsae
- Teams recognized Poomsae (3)
- Individual Freestyle (Male & Female)
- Mixed teams Freestyle (5)
- Freestyle Mixed Pairs & Individual recognized Poomsae (Masc. y Fem.)
