#### 6. COACHES

- All Coaches must have current WT POOMSAE certification.
- All Coaches must be 18 years of age or older.

#### 7. DRESSCODE:

- Coaches' attire shall be followed by WT rules.

# 8. ATHLETES:

Each participant must be a citizen of the country he/she represents. They must have a letter of endorsement from their respective National Federation.

# 9. UNIFORM:

- All athletes must wear an official WT Traditional or Poomsae uniform.
- Logos, team names, country, athlete's name will be allowed under WT uniform rules.
- Only the following will be allowed. WT, Pan American Taekwondo Union (PATU)
  approved uniforms, logos, team names, country, athlete's name will be allowed
  under WT uniform rules.

# 12. COMPETITION METHOD:

- Simple elimination for categories U30 and U40
- Direct cut Off system for all other categories

# 13. TIMES:

- RECOGNIZED POOMSAE: No more than 90 secs.
- FREE STYLE: 90 100 secs.

# 14.AWARDS:

- 1ST PLACE GOLD MEDAL
- 2ND PLACE SILVER MEDAL
- **3RD PLACE BRONZE MEDAL**
- 3RD PLACE BRONZE MEDAL
- **POOMSAE MVP (Male and Female Recognized and Free)**
- BEST COACH (Male and Female Senior)

# 15. WILDCARDS:

- Gold medal and silver medal winners will get a direct pass to the next Cadet, Junior or Senior Pan American Championship.

#### 16. CONDITIONS FOR PARTICIPATING TEAMS:

- Round-trip airfare, lodging, meals and transportation expenses will be paid by the participant or their respective MNA. Accommodation in official hotels is not mandatory.
- -No transportation will be provided by the Organizing Committee.











#### 17. GLOBAL WT LICENSE & ONLINE REGISTRATION:

- Global WT License Registration. All athletes and team officials must first be registered with a WT Global Athlete License (GAL) OR a WT Global Official License (GOL).
- Online registration in the WT (Simply Compete).
- Registration is only possible with a valid Global WT License.

# 18. COACHES & OTHERS:

- WT Global License Registration. All team officials must first have a WT.
- Global License. All team officials must first be registered with a WT Global.
- Official License (GAL).
- WT Online Registration (Simply Compete).
- All Coaches must be at least 18 years old.
- All coaches must have at least WT Coach Level 1.

#### 19. REGISTRATION FEES:

- The Organizing Committee shall collect the registration fees in dollars upon registration at the competition venue.
- Registered athletes and coaches will not be allowed to participate in the competition without payment.
- Registrations will be made at the offices of the Peruvian Taekwondo Sports Federation, 3rd Floor of the Peruvian Olympic Committee, Gate 3 of VIDENA according to the event schedule.
