5. OBJECTIVES:

Train and update referees and coaches across the continent on topics such as regulations for different competition specialties, including Para Kyorugi, Para Poomsae, Virtual TKD, Poomsae, and Kyorugi, refereeing techniques, and evaluation criteria, among others.

We want to promote uniformity and quality in decision-making during WT-standardized competitions, as well as promote the development of Taekwondo in the region with aspirations for international referee certification and all levels of coaching.

The seminar will be held in a virtual format to ensure the participation of a large number of referees and coaches from different countries. It will include theoretical and practical sessions.

At the end of the seminar, participants are expected to have greater confidence and preparation to perform their duties in Pan American and WT competitions, thus contributing to the growth and development of Taekwondo in our region.

Coaches and national/international referee of Poomsae and/or Kyorugi of all Pan American Federations.

7. Expected Results:

1. Improvement in the Quality of Refereeing: Referees are expected to acquire up-to-date knowledge that will enable them to apply more consistent and fair evaluation criteria during competitions.
2. Have solid preparation aimed at participating in international referee certification and the different levels of WT coaching and high-level events in the region and beyond.
3. The coach will have the foundation to develop a comprehensive class aimed at general practitioners and high-performance practitioners.

11. Test:

In order to obtain certification as a Pan American referee or coach, at the end of the congress there will be an evaluation using a multiple-choice questionnaire with a time limit for completion. In addition, referees will be given a practical test.

The minimum passing score for both tests (as applicable) will be 80% of the total.

The evaluation will include questions on each topic presented during the congress.

At the end of the test, the examinee will be able to see the score obtained.

All participants who comply with the schedules established in the call for applications will receive a certificate of participation. If accredited, they will receive a digital credential endorsing their Pan American Certification, which is valid for one year from the month in which they complete the course and/or until there is an update or change in the competition rules, in which case they will have to participate in the next refresh published by PATU Education.
